The first order of business is to discuss the draft local coverage determination

discussion. The first discussion today is DL3A211, corneal hysteresis. I'm

Robert Kettler: OK. Thank you, Dr. (Sheybani). This first draft LCD is a non-coverage policy

for all corneal hysteresis assessments as a means of risk assessment or

monitoring for progression of ophthalmic disease activity. And first I'll just ask

if there are any comments here in the room. OK. (Laura), then, we could take

any comments that there are on the line.

It provides the inclusion and exclusion criteria and summary of the evidence in support of the LCD. First,
